 - c. Deliberate on matters regarding a student where personally identifiable information about the student will necessarily be revealed by the deliberation – Tex. Govt. Code § 551.0821
 - d. Deliberation Regarding Security Devices or Security Audits; Closed Meeting. This chapter does not require a governmental body to conduct an open meeting to deliberate Tex. Govt. Code §. 551.076.
