Notice is hereby given that a meeting of the Board of Directors of the Hunt Memorial Hospital District will be held on July 28, 2026, at 5:30 p.m. for the purpose of considering the approval of a firm to perform all legal services necessary to collect delinquent property taxes and authorizing the execution of such agreement.

The agreement to be considered is necessary to collect the delinquent taxes owed to the Hunt Memorial Hospital District in the most effective manner. The District desires that such delinquent taxes, penalties, and interest be collected as provided in the Texas Tax Code on a contingent fee basis as provided in the Texas Tax Code Sections 6.30, 33.07, 33.08, and 33.48. Both the Linebarger and Perdue firms are qualified to provide this representation.

Approve Resolution authorizing a Twenty-Percent Penalty to defray Hunt Memorial Hospital District's costs of property tax collections ~Discuss, consider and, take action to ratify Resolution No. 371 authorizing the imposition of an additional twenty-percent (20%) penalty to be borne by the delinquent taxpayer to defray the costs of collection, as authorized by the Texas Property Tax Code §33.07 and §33.08, to compensate a private law firm for its attorneys' fees.
