[REDACTED] - I apologize for this going today; I thought the email was sent Friday. I'm confused because in the below email chain [REDACTED] stated that she is in your AOR and you would reach out.

She didn't respond because she was frustrated and in crisis. I told her that I would assist since it didn't appear that you or another VS would go meet her in person to help stabilize the crisis; and assist with appropriate trauma focused therapist referrals. She doesn't have victims compensation fund so that will not work. She sent me a link that she found for crime victims programs and I told her that I would assist in reaching out to them to coordinate services.
