Please forward the following message to Jeffrey Epstein:

Dear Jeffrey,

As we discussed, my piece on Prince Andrew, Duke of York, is scheduled to appear in the August issue of Vanity Fair, which will hit the newsstands on or around July 10th.

As promised, I'm getting back to you to check some facts.

1. There have been newspaper reports that the Duke of York arranged for you to give Sarah Ferguson £15,000 (\$24,500) to help retire her debts. I have a source who claims to know that Sarah Ferguson actually received hundreds of thousands of dollars from you. Exactly how much money has Sarah Ferguson received from you? And how were the payments made?

2. The Mail on Sunday in Britain obtained an interview with a young woman named [REDACTED], who claimed that you trained her as an underage prostitute and flew her to London in 2001, when she was 17 years old, for the purpose of spending time alone with Prince Andrew.
